Chief McMaster —“Thank God for CIT”

Greenville, Maine— In August of 2008, Police Chief Scott McMaster of Greenville was called to the Indian Hill Trading Post to deal with an individual who entered the store with a shotgun in an attempted robbery. The individual went directly to the sporting goods area and took a hand gun and bullets. At this point, the person specifically asked for the Chief McMaster by name stating he wanted the police to shoot him.

Chief McMaster had received CIT training when he worked in Kennebec County. He credited that training with helping him remain calm on the way to the scene. When telling of this incident, the Chief explained how the training taught officers to watch for

“triggers” which make the person become more upset, as well as learning techniques to avoid the escalation triggers. The other important information from his CIT training that helped was when the man pointed the gun at his own head, Chief McMaster refused to look away and told the man about the emotional consequences the Chief himself would have to live with as a result of being forced to watch him commit suicide.

During the episode, Chief McMaster shared the range of emotions he went through from anger at being put in the position of possibly being shot, having to shoot someone else, or having to see someone kill themselves. He credited

his ability to keep those emotions under control during the confrontation to the CIT training he had received.



The incident ended positively with the Chief talking the individual down to the point he turned over the gun and was removed

from the store. The Chief's response after this event was **“Thank God for CIT!”**

CIT EXPANDS IN THE HEARTLAND

Kansas — The Kansas Law Enforcement CIT Council has been contracted by the University of Kansas and the Kansas Law Enforcement Training Center to provide CIT training to Kansas Police Officers and Deputy Sheriff's all across the state. After receiving a donation from the Tower Foundation in Topeka, earmarked specifically for CIT expansion, plans were immediately under way to take CIT statewide. The plan calls for six 40 hour CIT classes over a period of 3 years in locations throughout Kansas. The goal is to bring CIT to smaller communities and areas where advanced training in mental health issues is not readily available. ## Community Collaborative:

### *Growth and Expansion of Southwest Louisiana's CIT Program*

Louisiana— The growth of CIT Southwest Louisiana has become a model for many agencies throughout many parts of Louisiana. A collaborative effort of law enforcement and community came together in support of the CIT program's development. The initial partnership consisted of NAMI Southwest Louisiana, Lake Charles Police Department, Calcasieu Parish Sheriff's Office, state's regional Office of Mental Health,

and McNeese State University's Psychology Department. These entities' partnership created a 40 hour CIT training program based at the university, taught free of charge by professors, mental health professionals, and law enforcement trainers (quarterly). The uniqueness of this partnership opened its training free of charge to all regional law enforcement agencies. The regional program soon became the

trainer and mentor to agencies through much of the state, training officers from Alexandria, Lafayette, Baton Rouge, and St. Tammy Parish near New Orleans. Several of these agencies have since either instituted their own 40 hour training program or are in the process of doing so. These agencies have based their program development from the Southwest Louisiana program's POST approved curriculum.
